Youth crime and delinquency control is subject to more media and political hype than perhaps any other topic, and its study lies at the origins of the sociological enterprise. This course will begin with an exploration of the conditions that generate delinquency, and then we will explore the legal practices intended to control it, especially focusing on the interaction between the police and adolescents.

The idea is to foster an intense, searching class discussion. A great deal of learning happens in discussion, when one's new ideas, guesses, hunches, ideological convictions, and moral persuasions rub unexpectedly up against others'. I will assist this process through my questioning in class, and want you to have challenged each reading so that you, in turn, can be challenged by others in class.

Please feel free to discuss topics further with me before class, or after class by appointment. *Be sure to exchange phone numbers with two or three other students and form study groups.*

Requirements

Students will be required to complete one take-home midterm exam (30%), summarize and critique the readings in class (20%), and write a term research paper (40%) which will be presented to the class towards the end of the semester (10%).
