## FedEx employees coming to The Market on Poplar

FedEx has signed two leases for space in The Market on Poplar shopping center in the former Albertson's supermarket location.

FedEx spokesman Jim McCluskey said the company signed the leases within the past two weeks.

Plans are for FedEx Corporate Services to occupy 34,173 square feet at 890 Poplar. The majority of the space will be used for "developmental training for employees" to help expand and enhance their skills, McCluskey said. FedEx Express will occupy some of the space, he said.

The space the company currently uses for training at the

FedEx World Tech Center in Collierville will be converted into office space for employees, McCluskey said.

Modifications to the building will begin soon, and FedEx expects to occupy the building in early 2009, he said.

Other businesses in the shopping center on the northeast corner of Poplar Avenue and Market Boulevard include Patton Computers, Memphis Pool, CiCi's Pizza, Jackson's Shoes and Hobby Lobby.

### Small business association endorses Norris and Todd

The National Federation of Independent Business (NFIB), an association for small businesses, announced Tuesday that incumbents Senate District 32 Sen. Mark Norris and House District 95 Rep. Curry Todd, both of Collierville, are among the candidates it is endorsing in 56 legislative races.

July 31: Vandalism under \$500 – Resident on Andrew's Way reported that he noticed one of the glass panes in the home's backdoor was broken when he got up that morning to take his dog out. Responding officer found no signs indicating entry was gained. Resident requested extra patrol.

July 31: Aggravated Burglary – Officers responded to a call about a burglary at a home on East Lawnwood at approximately 2 a.m. The victim told police that someone had stolen a steel safe containing \$2,985 from his second-floor bedroom and that items on top of the safe had been moved. The owner of the house said that everyone in the home except his grandmother had gone to a party that night. The grandmother, who had been asleep in her bedroom, reported she didn't hear or see anything unusual. Officers noted that someone trying to enter through the second-floor bedroom's window, reported to have been unlocked, would have to go over the roof from the rear of the house. Items that had been moved from the top of the safe were processed and photos of the room were taken.

July 31: Aggravated Burglary – Officer responded to a call about a theft from a vehicle in an open garage at a home on Bradford Trace. July 31: Misuse of Registration; Manufacture, Delivery, Sell of Controlled Substance – An officer pulled over the driver of an Oldsmobile Cutlass Cierra he observed weaving as it was headed westbound on Poplar Avenue near Main Street. With the driver's consent given, the officer searched and found marijuana "roaches" in the ashtray and one in a tackle box. The total weight of the roaches and the bag that contained them was roughly 2 grams.

The store's loss prevention manager had a 21-year-old Collierville resident in custody for stealing jewelry, including a watch, and clothing. Aug. 2: Driving Under the Influence; Driving with Suspended License – An officer checking businesses around Merchants Park Circle at approximately 4:20 p.m. observed the brake lights of a Ford Taurus with a Tennessee license plate reflecting off the front of Eddie Bauer's. The officer observed two men in the car. The 30-year-old driver, whose address was listed in Memphis, was on a cell phone and told the officer he was looking for Houston Levee. The passenger appeared to be asleep. The driver had watery eyes, was confused, swayed when he stood and performed poorly on the sobriety test. The driver said he and his passenger had been to a club on Beale Street and were meeting some girls on Houston Levee. The driver tested at .114 on the breath test and was arrested.

Aug. 2: Suspended License; Simple Possession of Marijuana; Possession of Drug Paraphernalia – Officers stopped a vehicle at Poplar Avenue and Hwy. 72 for having a tinted cover over the license plate that obstructed the view of the plate. The 27-year-old male driver, of Murray, Ky., had a suspended license. The driver said he had marijuana in the vehicle. A search produced roughly 2 grams of marijuana and a metal smoking pipe with marijuana

Aug. 4: Theft of Property under \$500 - Officer responded to a call from World Market, 4600 Merchants Park Cove, Ste. 121, about a fraud complaint. The store manager advised the officer that his review of security camera footage showed a 35-year-old male employee making transactions at the register, using store items he never purchased and taking the refunded money, \$130.01, on July 23. The manager showed a statement admitting to the theft signed by the suspect, who was taken into custody and searched. Three grams of marijuana were found in his pants pocket and a glass jar with a rubber-sealed lid covered inside with marijuana residue was found in his vehicle, along with a marijuana blunt in the ashtray.

Aug. 4: Theft of Property over \$1,000 – Officer responded to a call from World Market, 4600 Merchants Park Cove, Ste. 121, about a fraud complaint. The store manager advised the officer that a 28-year-old female cashier had signed two confessions to charging \$1,725.52 worth of fraudulent cash refunds and store gift cards and store surveillance video also was available.
