#### **Veterinary conditions:**

All exhibiting cats must be healthy and free from infections and parasites. All cats must have a valid vaccination certificate, with the necessary vaccination against rabies, panleukopenia and respiratory viral diseases. The vaccination implemented not earlier then one year and not later than one months before the date of exhibition.

The owners of white cats must have the veterinary certificate of the examination of the cat's hearing.

#### The show program for either days:

7,00 - 9,00	entrance and veterinary check-in
9,00 - 9,30	corrections, checking class
9,30 - 15,00	judging cats and nominations
16,30 - 18,00	Best in Show
18,00	end of the show

If necessary, changes in the programme are possible.

#### Warning:

Registrations and cancellations will not be accepted after 20<sup>st</sup> May 2006 (closing date). If you will leave the show earlier without allowed, you will be named on the black list

If you will leave the show earlier without allowed, you will be named on the "black list" and the cat's result will anull.

The participation at the show is at one's own risk. The exhibitors can present their cats to the judge themselves, the stewards will be available as well. The protests against the exhibiting rules or conditions can be given in written form with the fee 10 € during the show. In the case of the wrongful protest the fee fall through the show's benefit. The changes of class you can report to the show council till 9.00 o'clock at the latest. The apologies of the animals will be recieved only from the person, who has the animal apply for.
