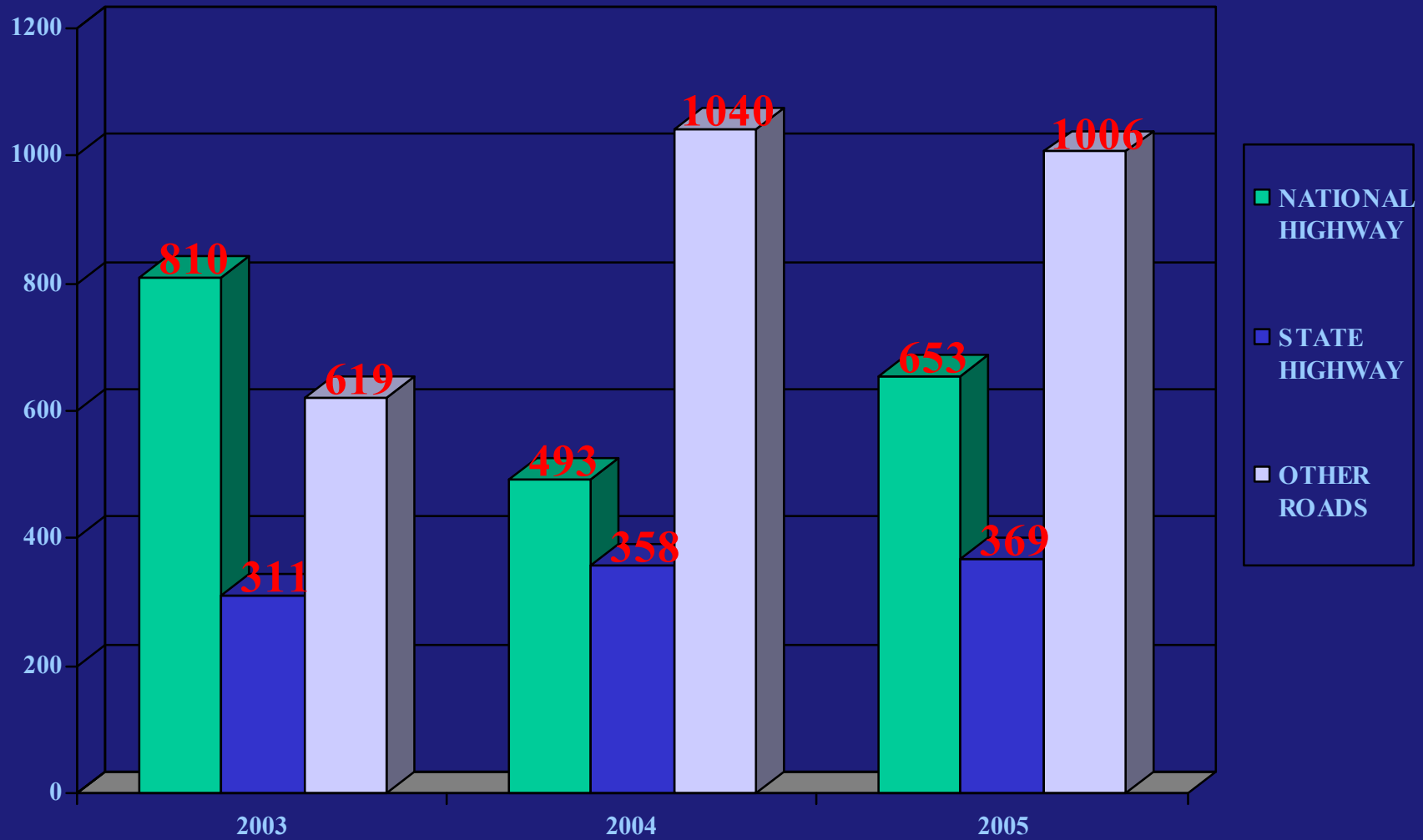
ROAD ACCIDENTS NON FATAL



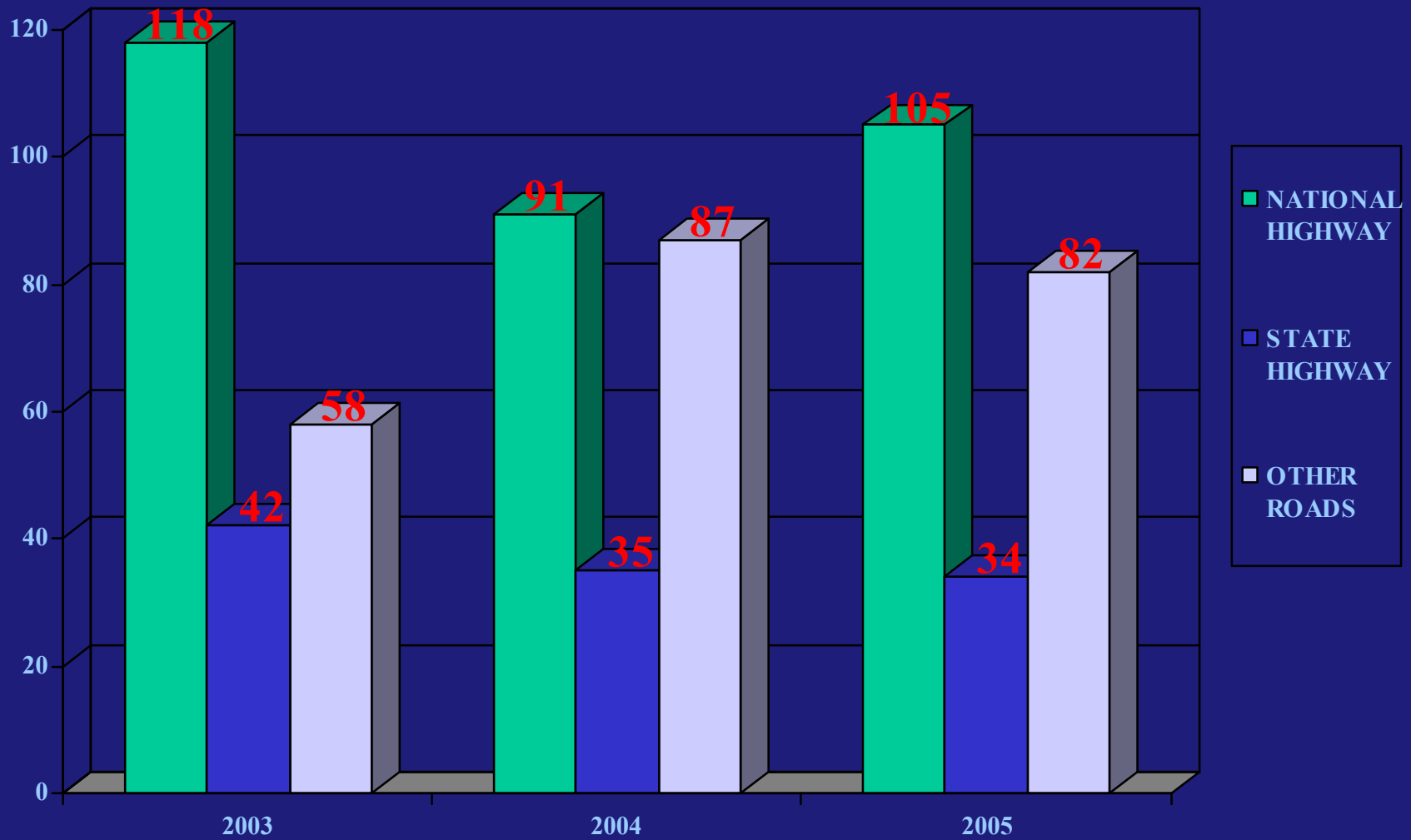

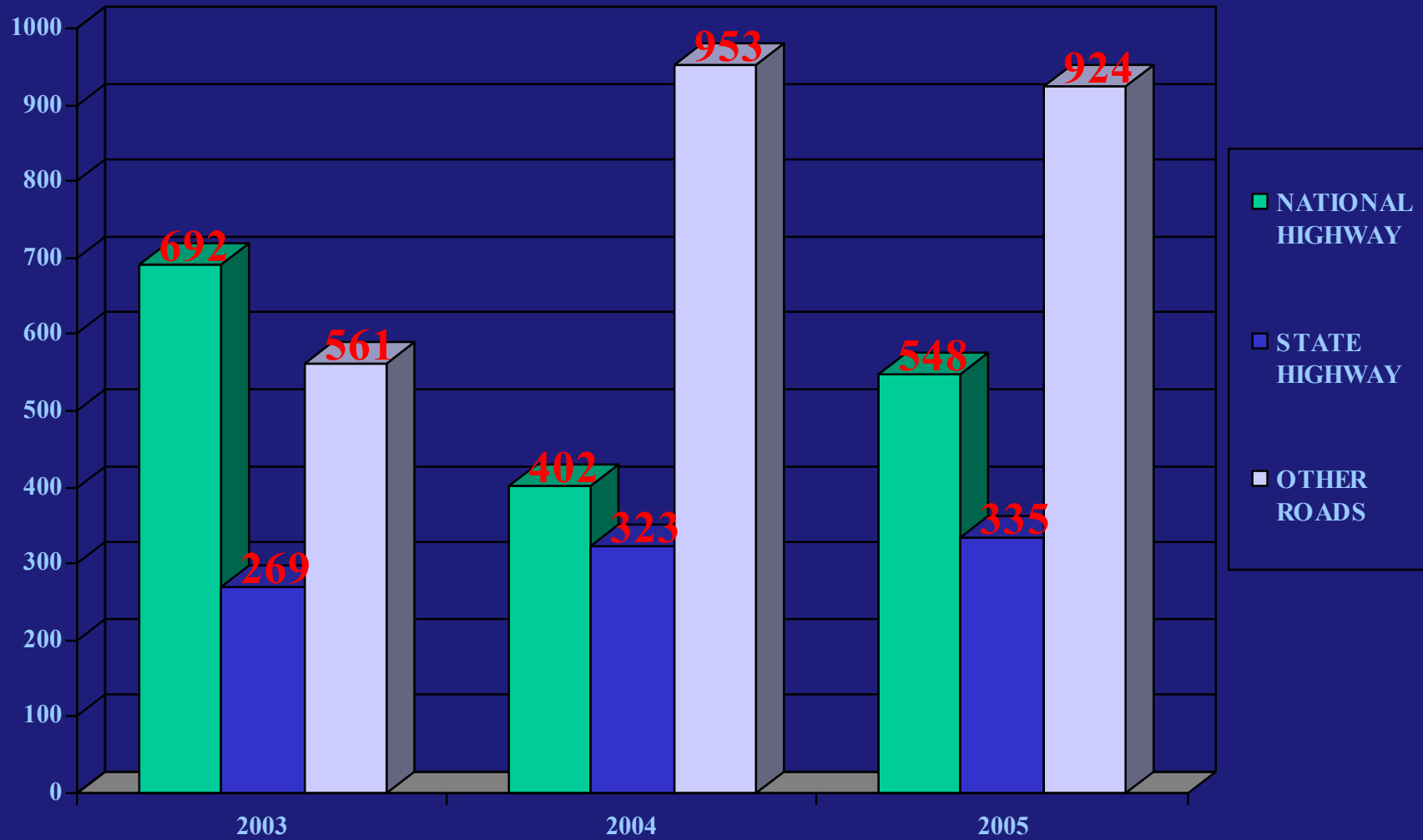
ROAD ACCIDENTS - ROAD TYPE WISE



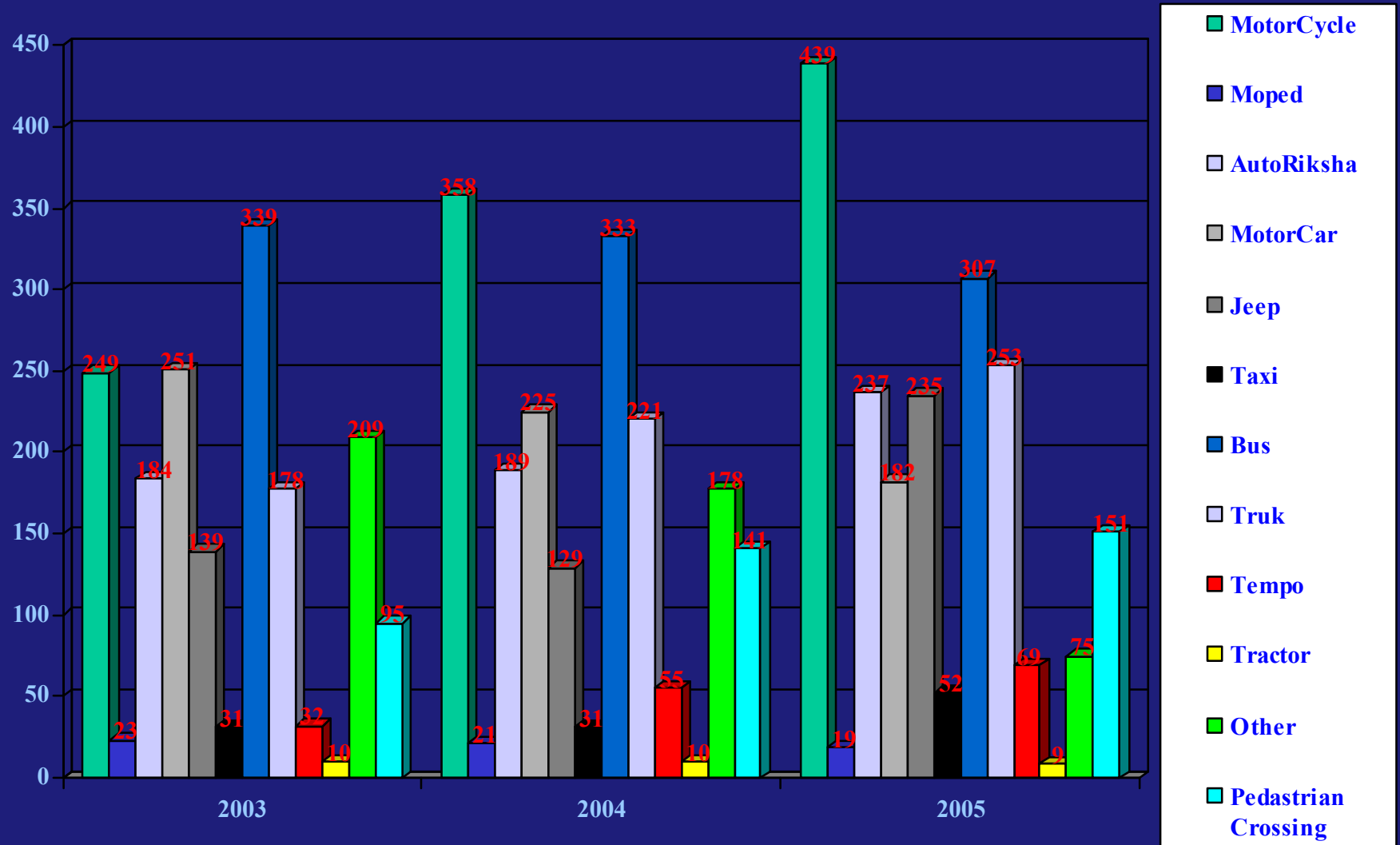

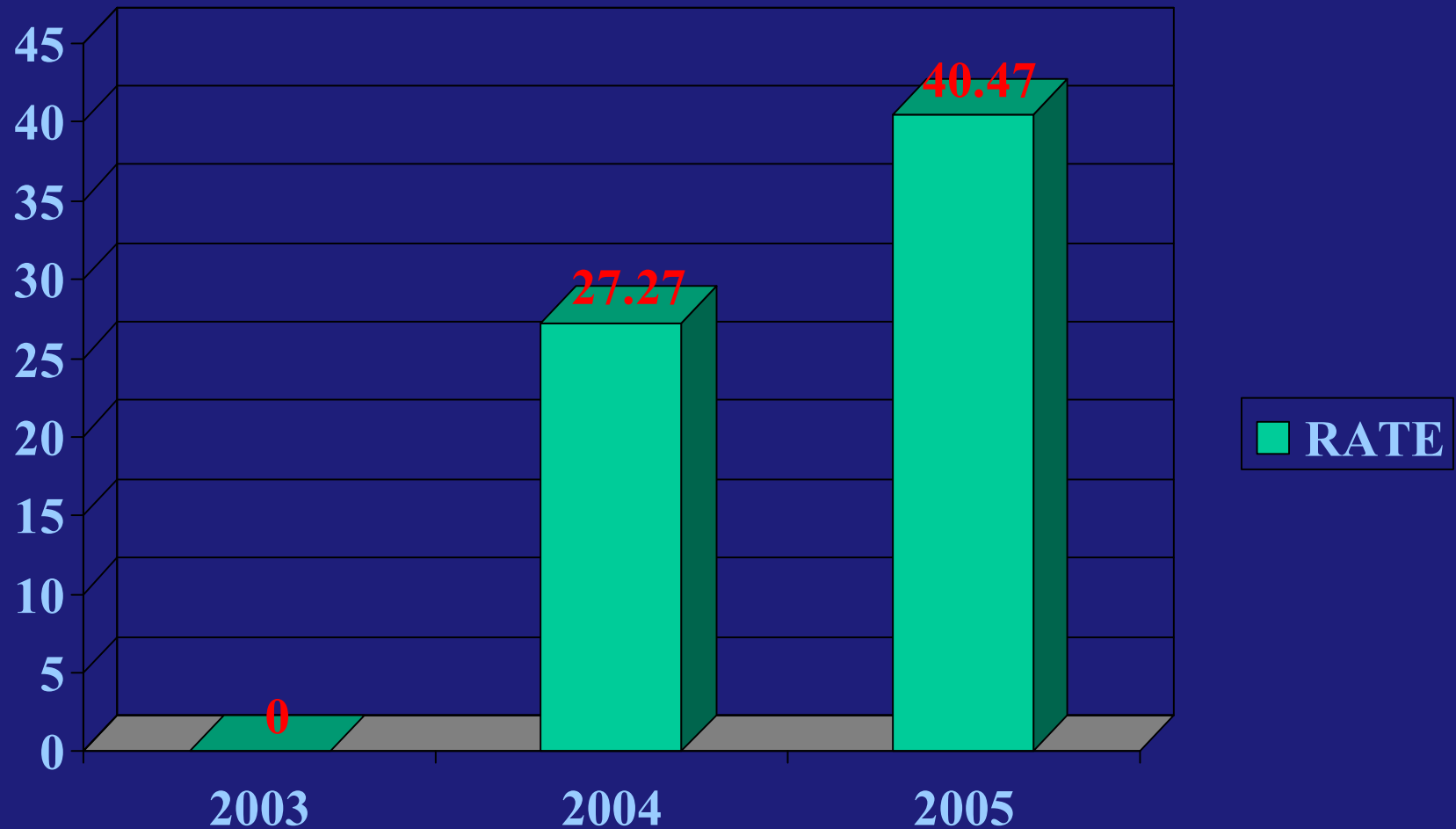
RATE OF CONVICTION FOR MURDER CASES

RATE OF CONVICTION FOR BURGLARY CASES

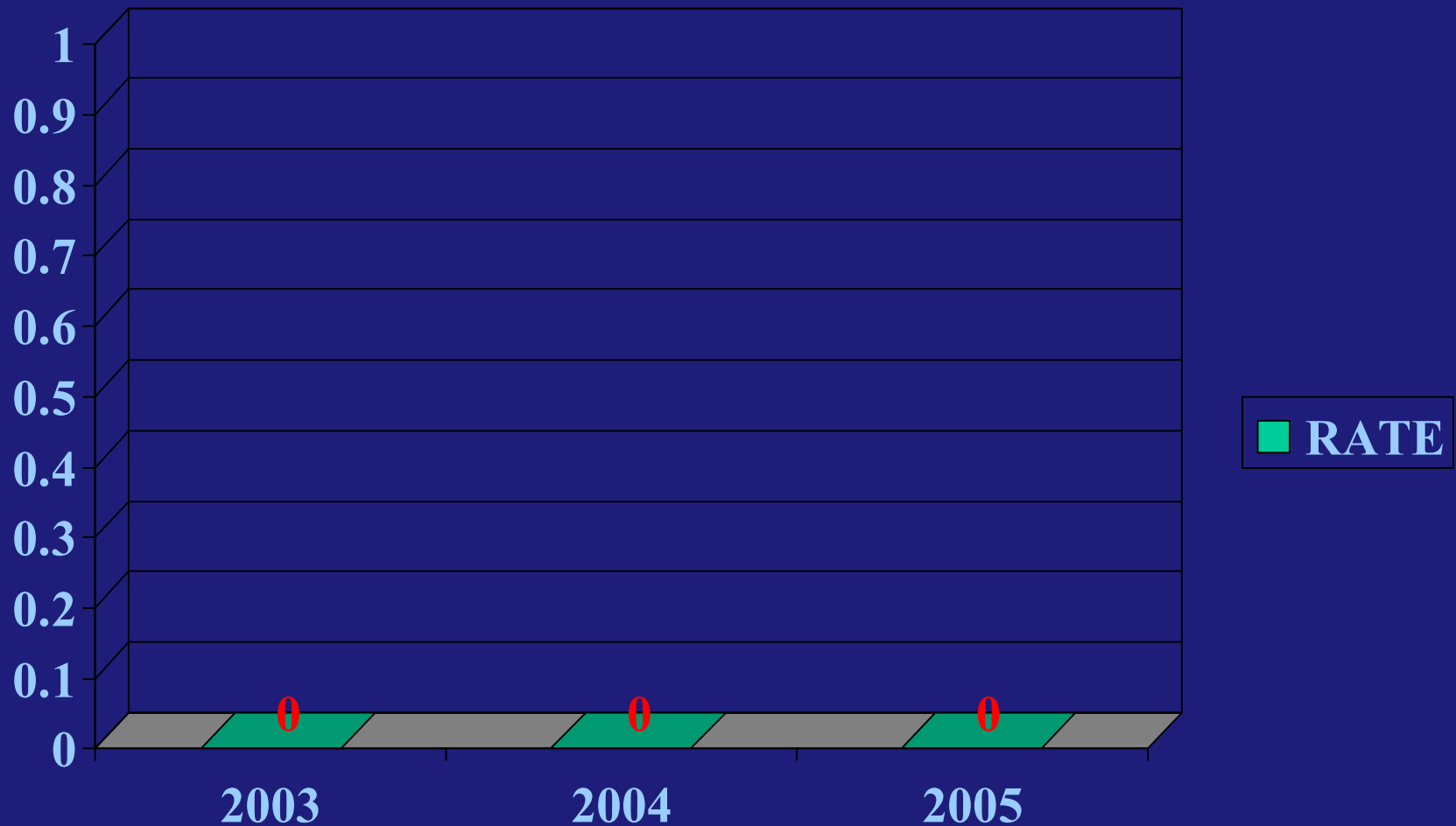

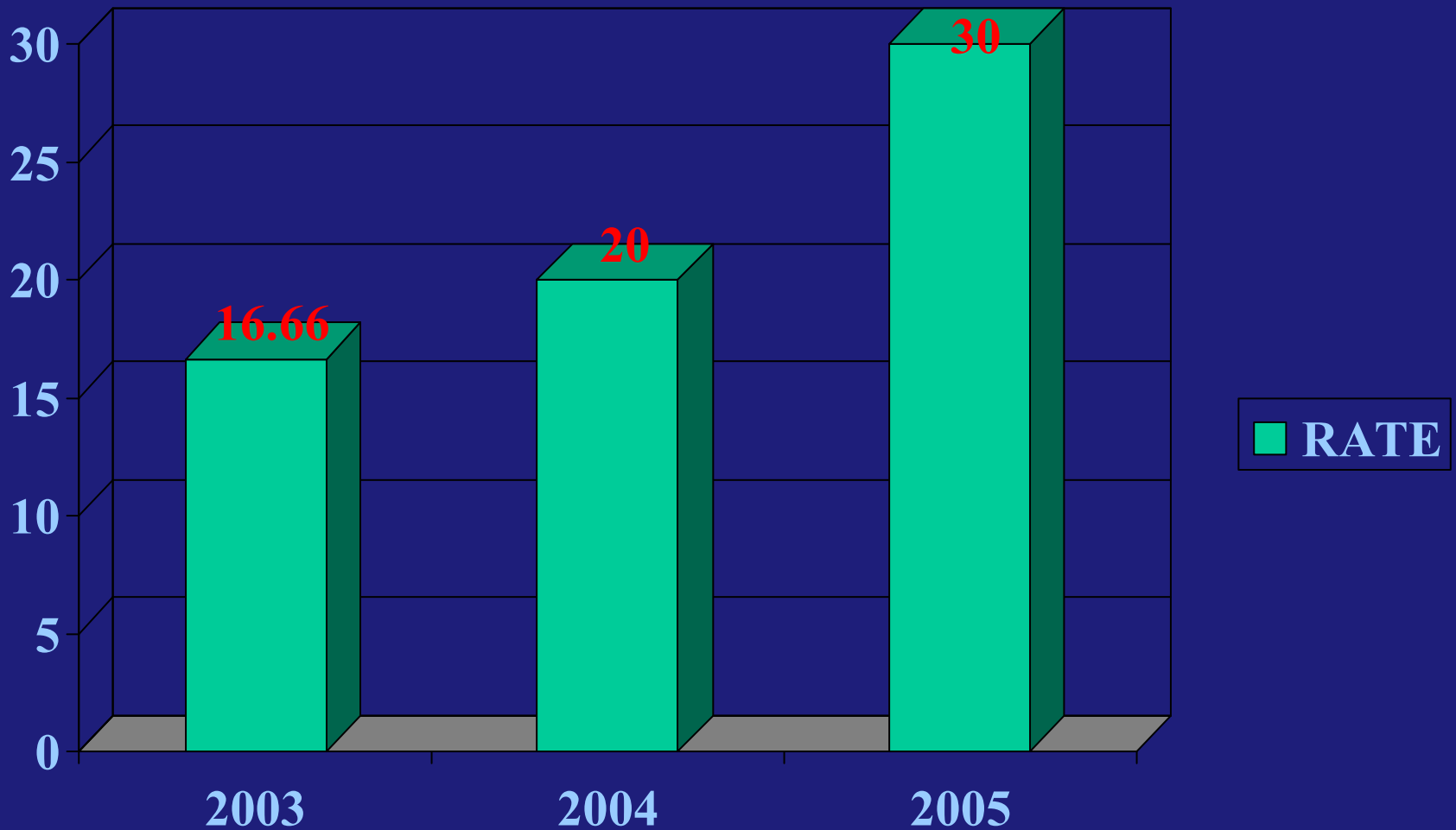
RATE OF CONVICTION FOR DACOITY CASES

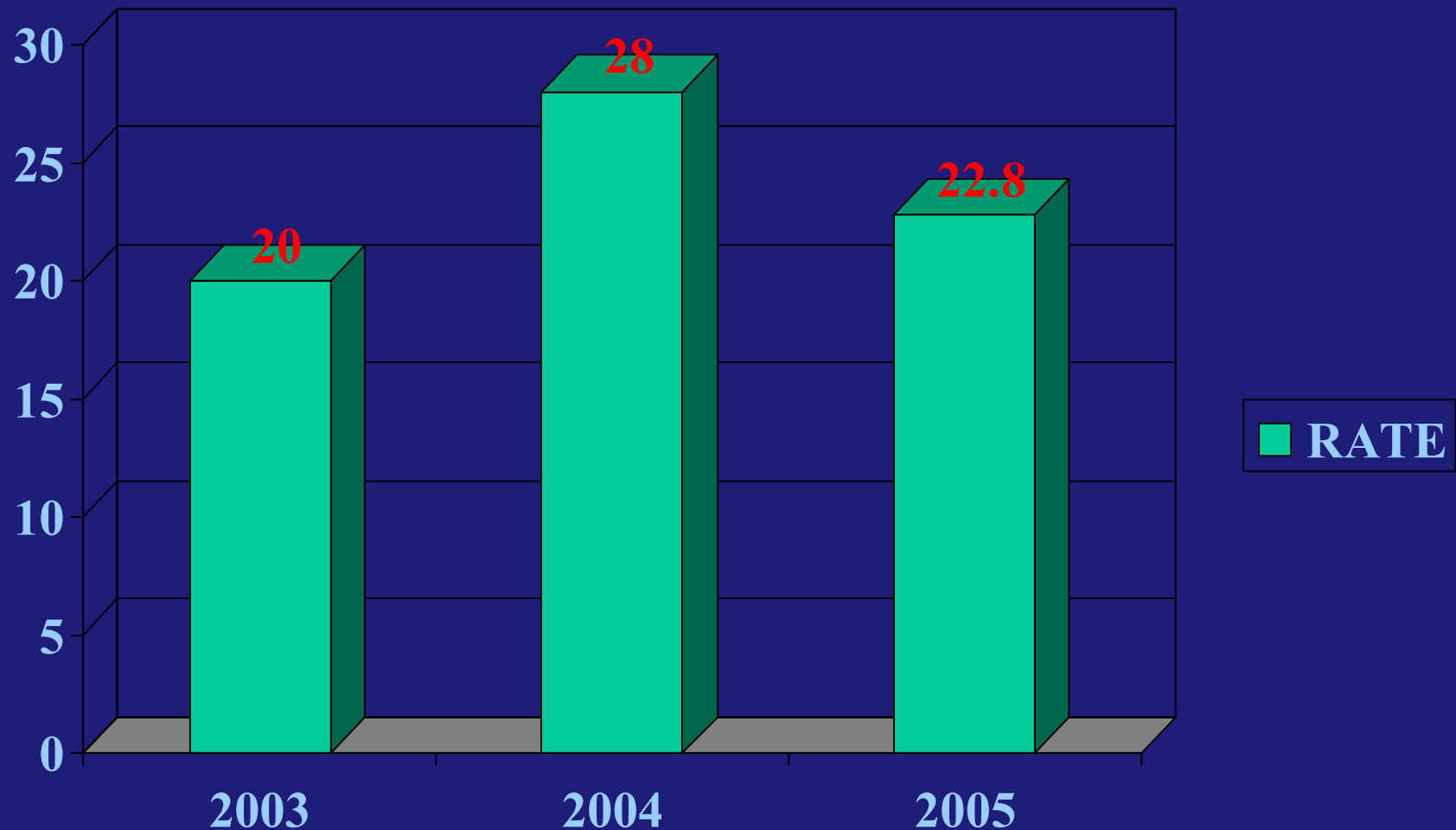

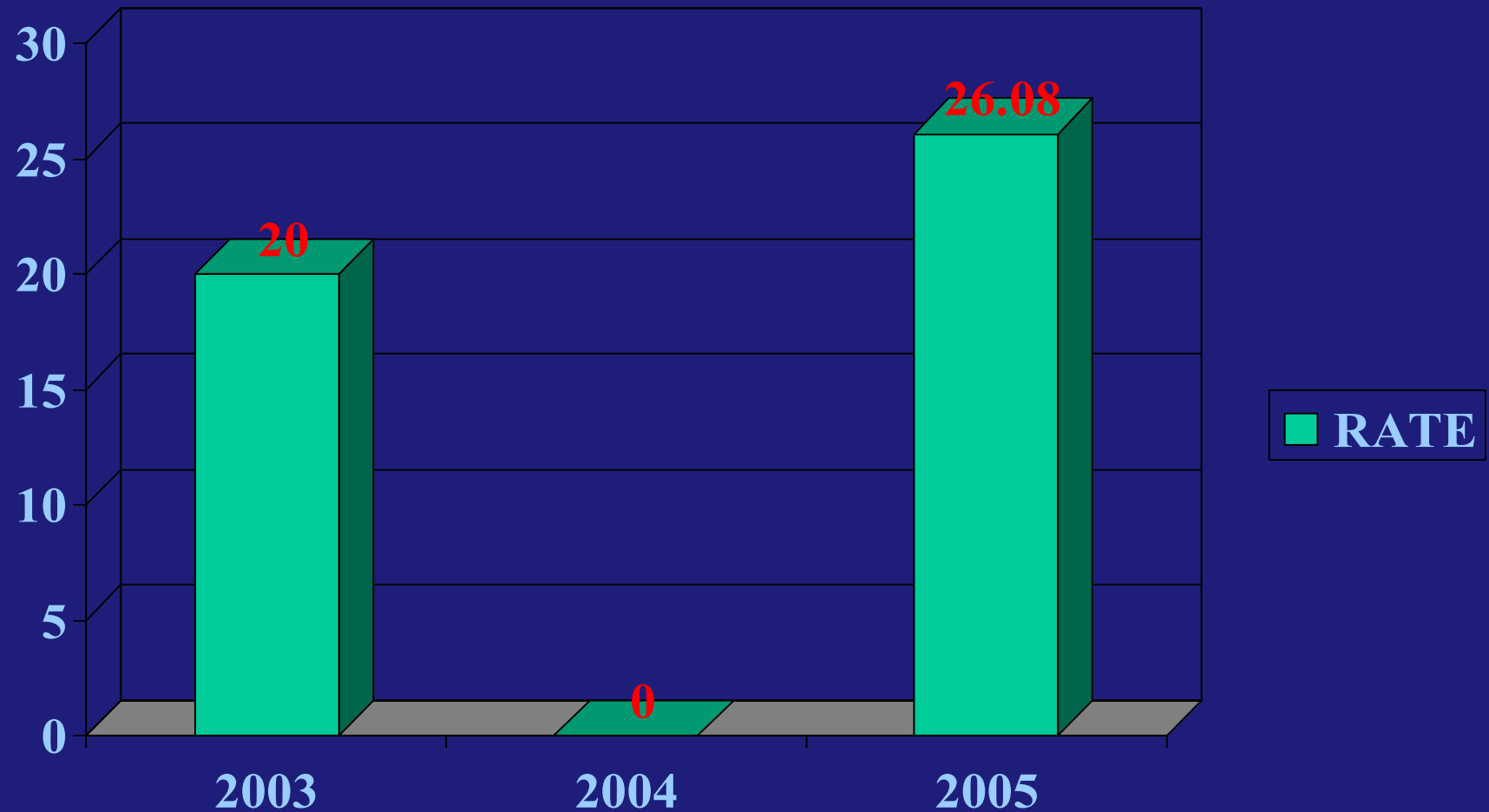
RATE OF CONVICTION FOR THEFT CASES

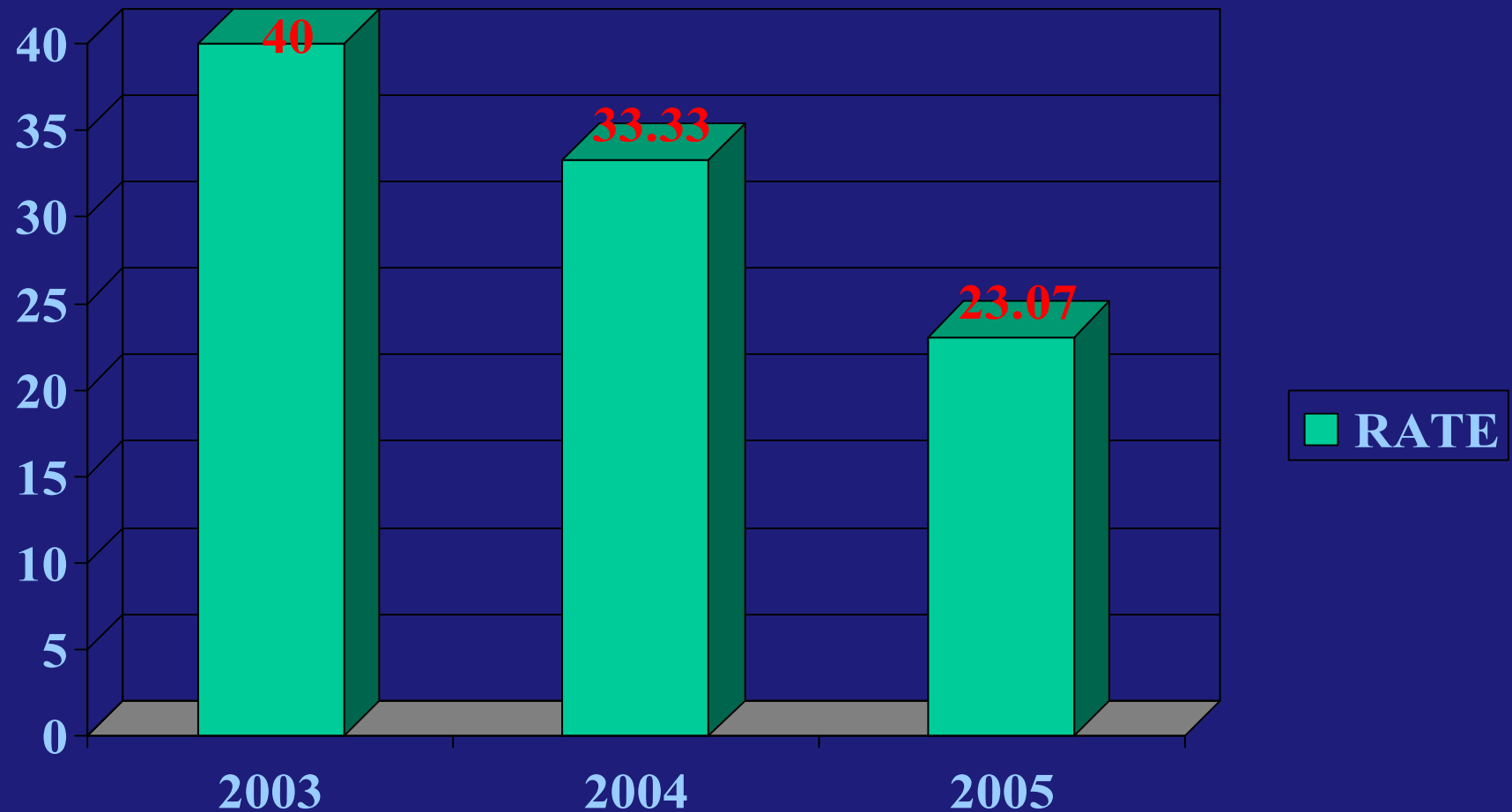
RATE OF CONVICTION FOR CHEATING CASES

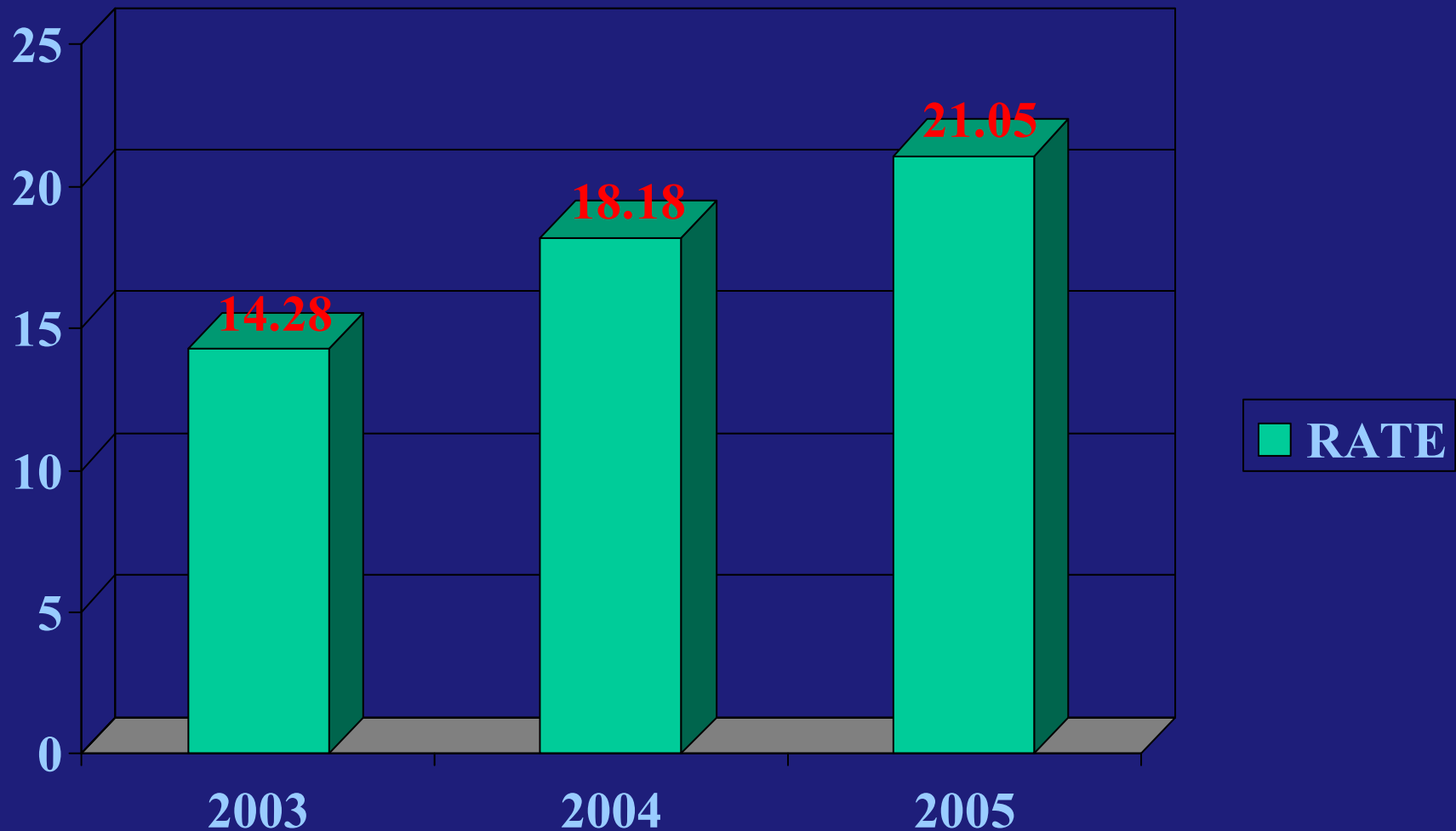
RATE OF CONVICTION FOR CR.BR.TRUST CASES

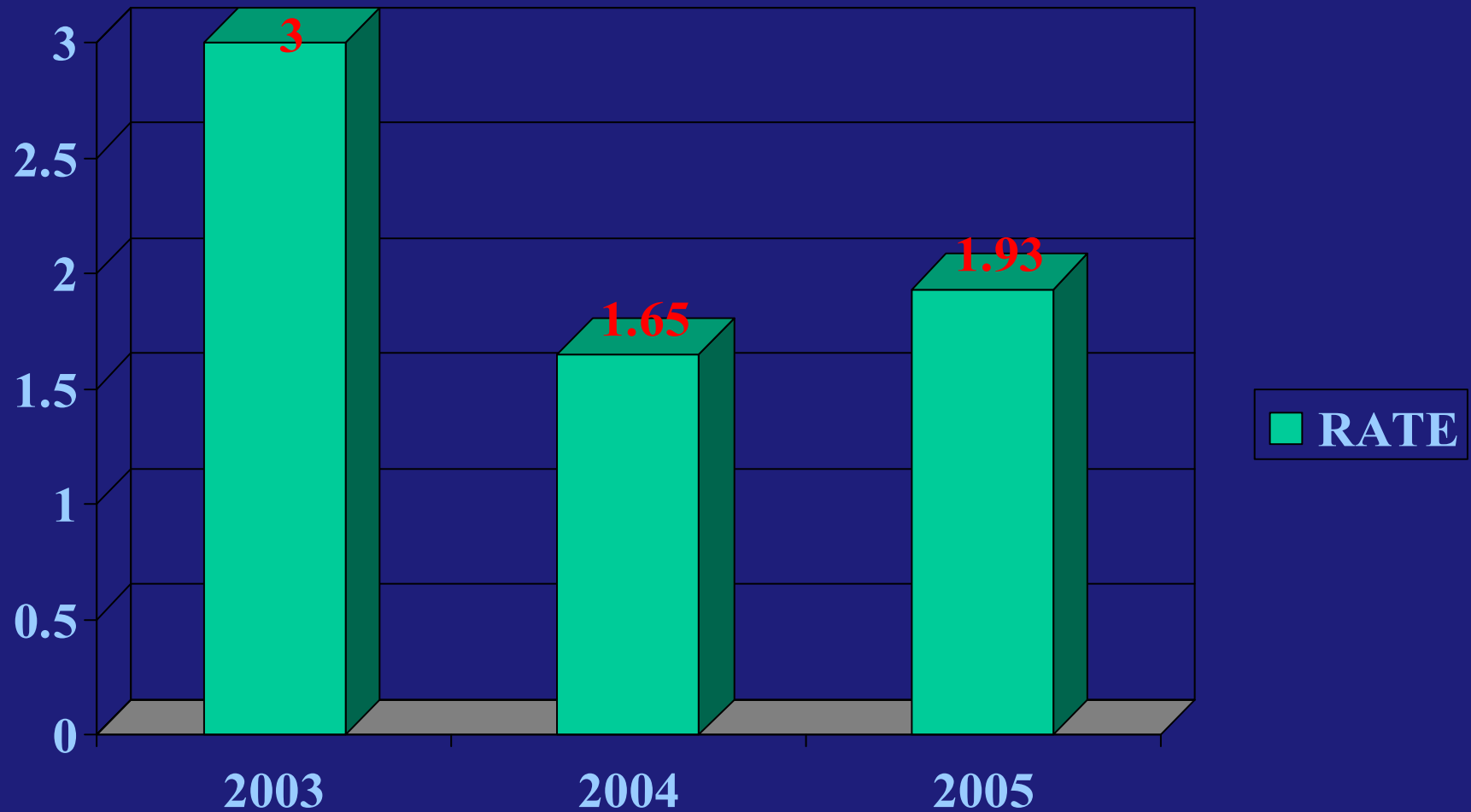
RATE OF CONVICTION FOR ATTEMPT TO MURDER CASES

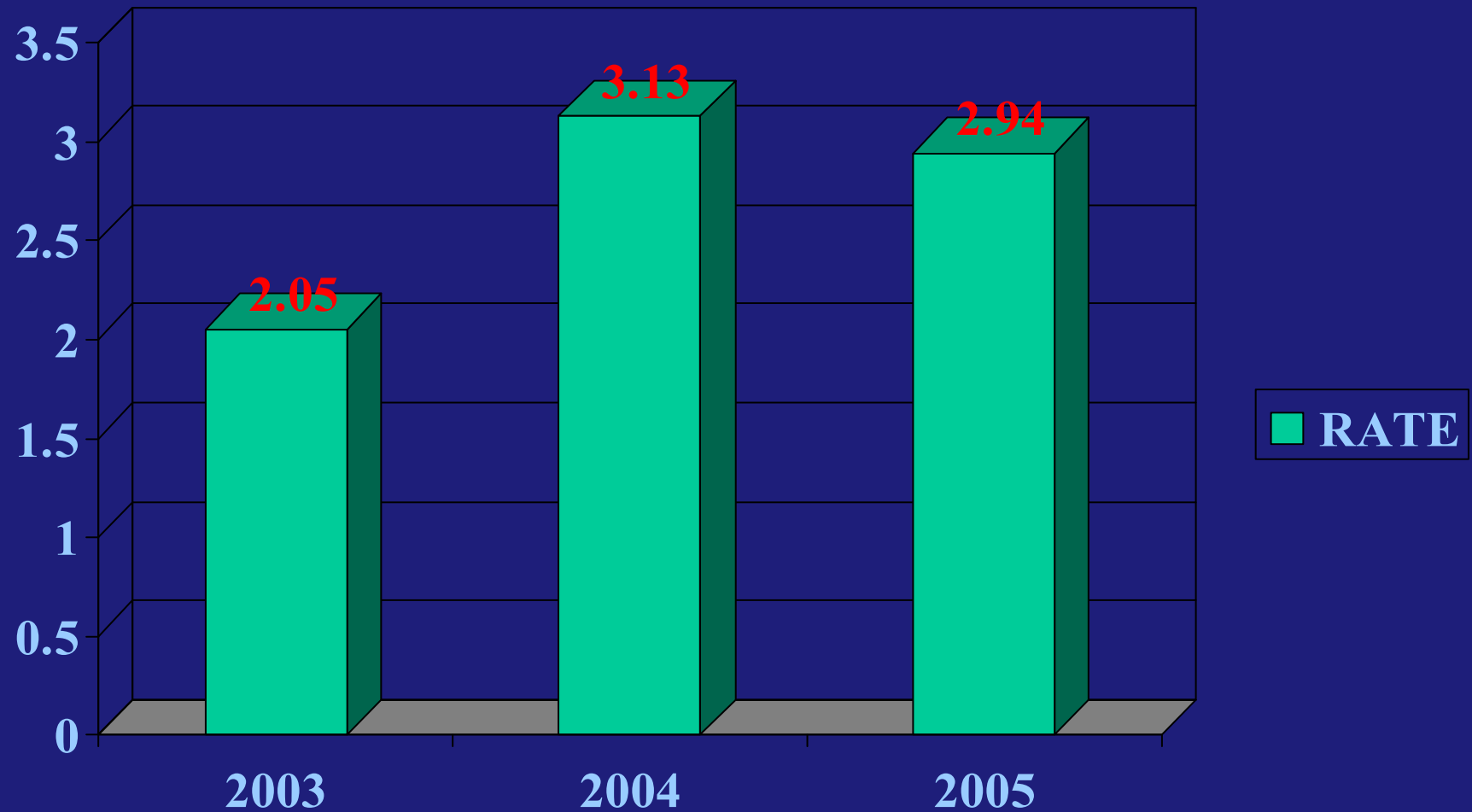

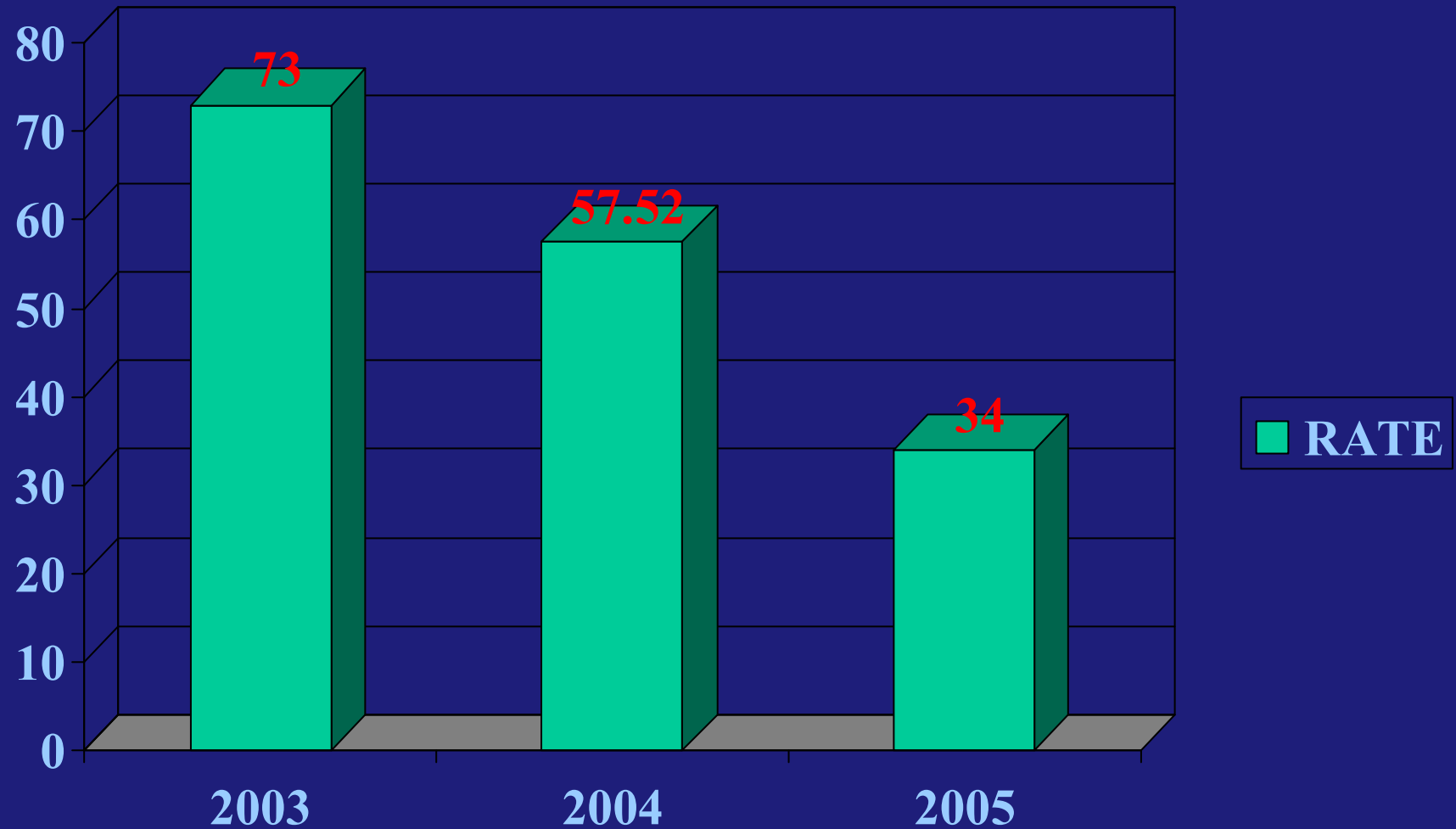
RATE OF CONVICTION FOR HURT CASES

RATE OF CONVICTION FOR CRIME AGAINST WOMEN CASES



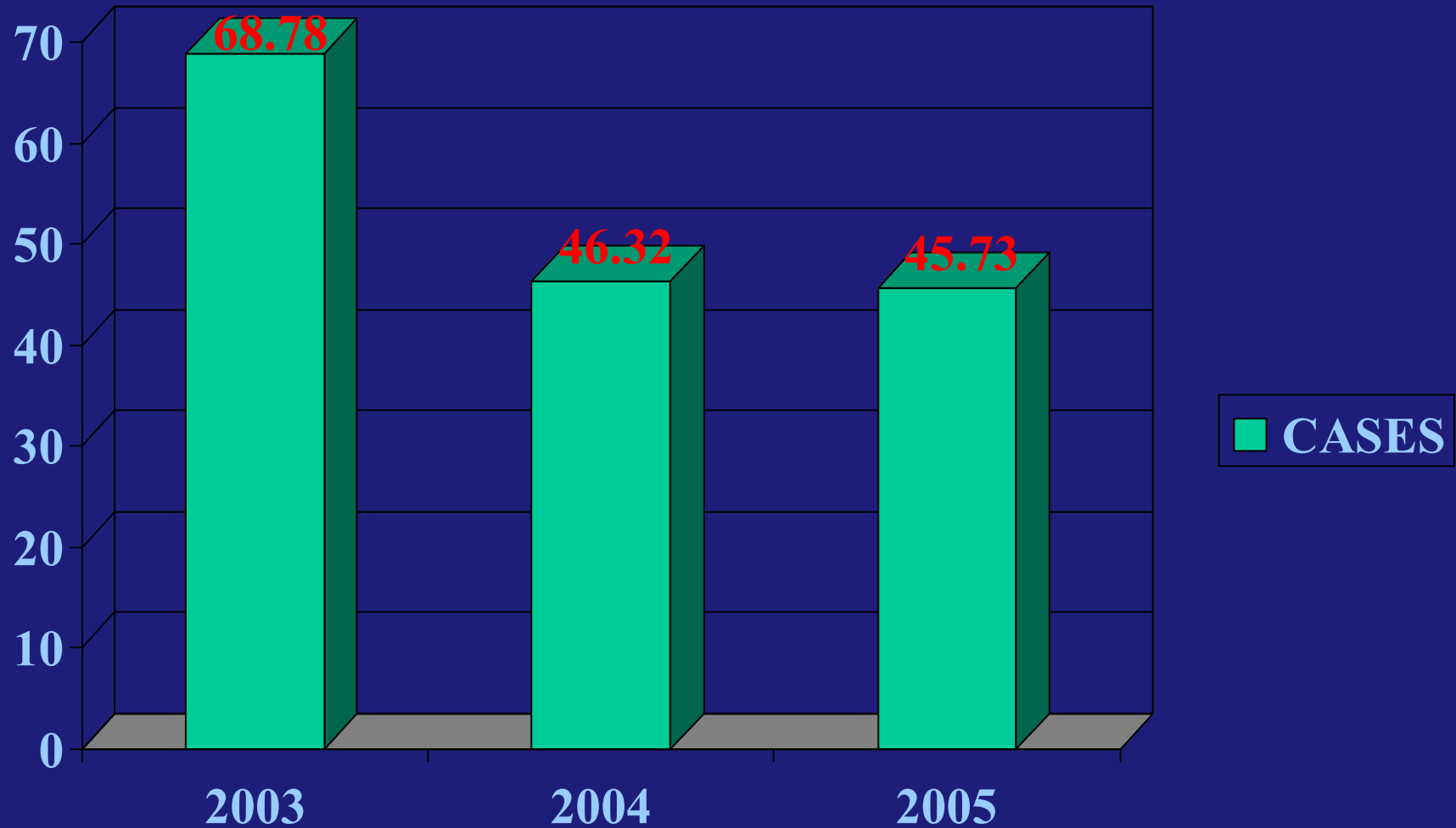
RATE OF CONVICTION FOR IPC CASES



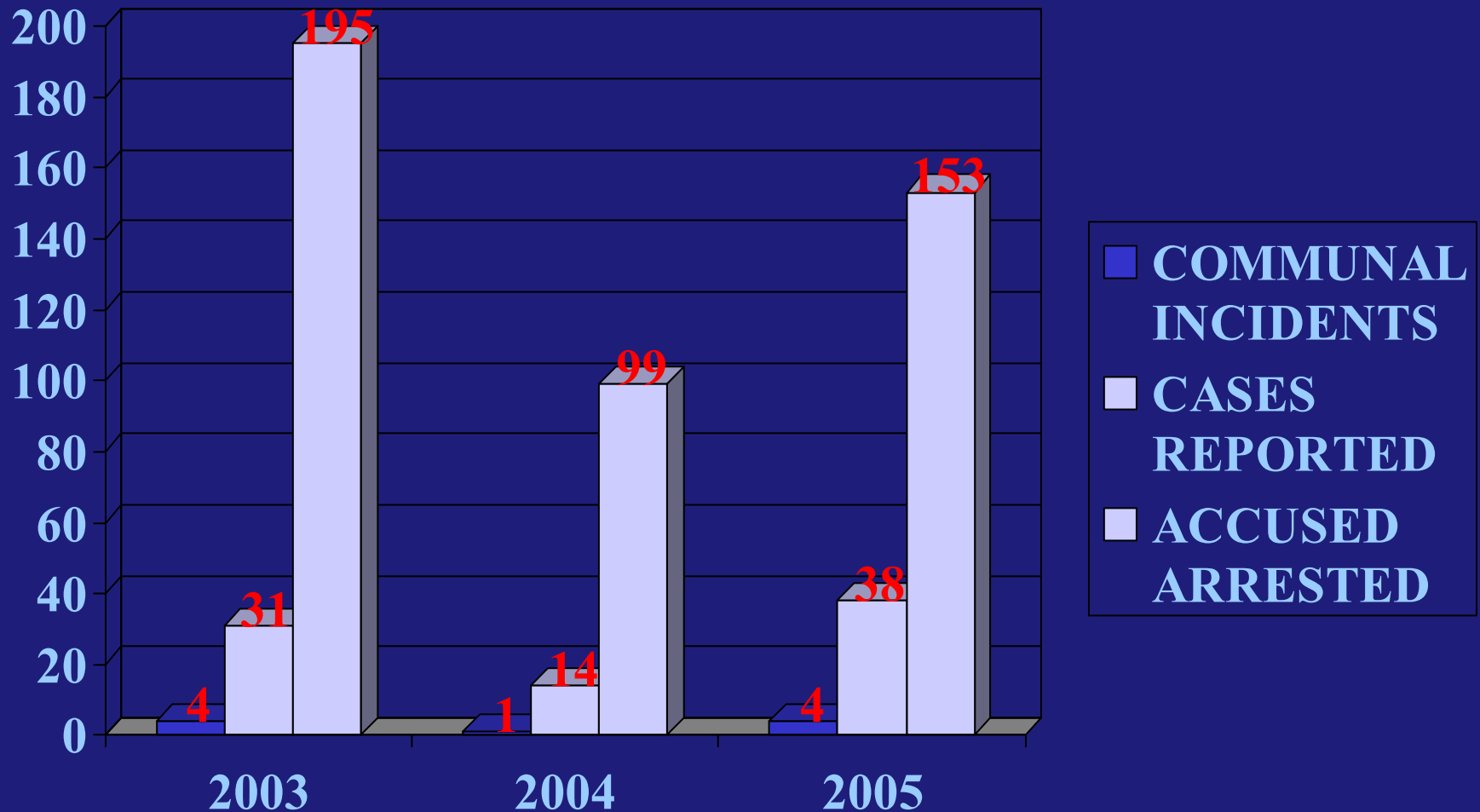

IMPORTANT CONVICTIONS

- In the year 2004, in 02 cases of murder the accused have been convicted with Life Imprisonment
- In the year 2005, in 03 case of murder the accused have been convicted with Life Imprisonment

Notable Detections

- 1. In the year 2004, 32 cases of chain snatching were detected and 32 gold chains recovered by Mangalore East PS staff.**
- 2. In the year 2005, 12 cases of chain snatching were detected and 12 gold chains were recovered by Mangalore Rural PS staff.**
- 3. In the year 2004, 02 cases of counterfeit currency were detected and fake currency worth Rs. 66,000 recovered and 26 persons were arrested by Subramanya PS Staff**
- 4. In the year 2005, 03 supporters of Naxalites were arrested and arms, ammunitions, cash & vehicle recovered by the Anti Rowdy Squad**
- 5. In the year 2005, 01 case of counterfeit currency was detected and fake currency worth 7,500 recovered and 2 persons were arrested**
- 6. In the year 2005, 01 case of counterfeit currency was detected & fake currency worth Rs 1,05,500 , Cash Rs 26,500 , fake US Dollar 1,600 & 6 persons were arrested by the Anti Rowdy Squad**

- 2. Effective Night Round and Night Beat system for the entire district.**
- 3. Appointment of CPIs and DY SPs as ‘Nodal Officer’s for non-heinous and heinous cases respectively to supervise the investigation of crimes right from registration to charge sheet.**
- 4. Refresher courses for Writers/I.O Assistants about record maintenance and investigation**
- 5. Action being initiated on those giving false/bogus complaints to the police u/s 182, 211 IPC.**

Anti Rowdy Squad

- The Anti-Rowdy Squad of D.K. District was first set up in the year 1995 to curb the growing menace of rowdies / underworld persons. Since then it is working efficiently, curbing the activities of rowdies / underworld persons, detecting many major sensational crimes, avoiding many Communal incidents and has stamped its mark in D.K. district.**
- Presently it is having a strength of 01 PSI, 01 ASI, 02 H.C's, 09 PCs and 01 APC who have been taken from various police stations of the district on OOD.**
- Proposal for the Creation of full-fledged Anti Rowdy Squad for the district is under Consideration with the Government.**

Anti Rowdy Squad

- 1. Nabbed one Balakrishna Shetty @ Vikki of Vittla, a close associate of Chota Rajan, seized from his position an imported pistol with 03 rounds worth Rs. 2 lakhs and a Maruthi Zen car worth Rs. 1.05 lakhs vide Mangalore North PS Cr.No. 41/05 Arms Act.**
- 2. Detected an illicit arrack packing unit at Puttur Kabaka, arrested 03 persons & seized packing machine worth Rs 1 lakh and arrack sachets vide Puttur Town PS Cr. No. 52/05 Excise Act.**
- 3. Arrested notorious communal goondas Asgar Ali, Bodda Lathief and Nazir of Ullal wanted in the murder of Polali Ananthu vide Bajpe PS Cr.No.91/05 U/s 302 IPC**
- 4. Arrested 10 associates of notorious underworld criminal Bannanje Raja by name Naveena, Pradeep, Guruprasad, Ziauddin, Aslam, Asif, Manoj, Devaraj, Mohammed Ali and Nikhil Shetty who had assaulted one Richard Pinto of Souza Sterionics and looted his shop at gun point and seized from them an imported revolver worth Rs 1 lakh with 3 rounds, a knife and 2 cell phones and Maruthi Zen Car worth Rs 1 lakh from their possession vide Mangalore East PS Cr. No. 68/05 U/s 395 IPC.**

5. **Arrested a rowdy by name Jagadisha of Karkala, an associate of notorious rowdy Narayana Salian at Moodabidre and recovered from his possession an imported revolver with 03 rounds worth Rs 1 lakh vide Moodabidre PS Cr. No. 105/05 Arms Act.**
6. **Arrested one Ganesh Salian brother of notorious rowdy Narayana Salian and another by name Roy Changappa who were wanted in a kidnap for ransom case in Chitradurga district and seized from their possession a Tata Sumo worth Rs 2 lakhs vide Chitradurga PS Cr. No. 353/05 U/s 364 (A) IPC.**
7. **Arrested 03 persons by name Venkata Reddy of Nalagonda (A.P.), Mohammed Sayyad of Kolar and Madhusudan of Bairapur Hassan, a notorious gang illegally supplying arms to Naxal outfit of Andhra Pradesh and recovered from them a Pistol and a Revolver in all worth Rs 3 lakhs, Cash Rs 3.70 lakhs and a Tata Sumo worth Rs 2 lakhs vide Mangalore North PS Cr. No. 317/05 Arms Act.**
