- 3) Refusing to accept/process ADA accommodation requests and discrimination complaints filed on CDC forms 1824 -- CCR15 §§ 3084.2(a), 3085;
- 4) Refusing to accept grievances accompanied by supporting documentation referenced as exhibit material and thus necessary for clarification -- CCR15 §§ 3084.2(a)(1), 3084.2(a)(2);
- 5) "Losing" and refusing to accept grievances at informal level --CCR15 § 3084.2(b);
- 6) Confiscating assisted grievances from cells and then taking reprisals against prisoners for assisting others -- CCR15 §§ 3084.2(d), 3084.1(d);
- 7) Intimidating primary grievants into withdrawing group appeals -- CCR15 § 3084.2(f);
- 8) Failure/Refusal to direct responses to first/next prisoner on list of group grievants when primary grievant transferred or released --CCR15 §3084.2(f)(3);
- 9) Staff below level of CCII allowed to screen, categorize, reject, and otherwise coordinate grievances -- CCR15 § 3084.3(a);
- 10) Rejecting ("screening") grievances for unauthorized reasons not listed at subsections (1)-(3) --CCR15 § 3084.3(c);
- 11) Rejecting grievances based on demand for informal-level review even though informal level is waived or bypassed by regulation -- CCR15 §§ 3084.3(c)(4), 3084.5(a)(1), 3084.5(a)(3)(A), 3084.5(c)(3)(G);
- 12) Rejecting grievances based on arbitrary/capricious demand to include documentation neither supporting nor necessary to clarify grievances -- CCR15 §§ 3084.3(c)(5), 3084.2(a)(2);
- 13) Rejecting grievances submitted either timely or untimely despite merely "directory" nature of time limits, failure of which to meet does not preclude further pursuit of grievances; also, refusing to accept "late" grievances which were timely submitted but delayed by prison mail system, staff, and/or because grievants had no time to file within prescribed (not mandatory) time constraints --CCR15 §§ 3084.3(c)(6), 3000.5(f);
- 14) Rejecting grievances based on misinterpretation/misapplication of "appeal system abuse" criteria -- CCR15 §§ 3084.3(c)(8), 3084.4;
- 15) Pejecting grievances with nonstandard CDC form 695 (Rev. 5/83) -- CCR15 § 3084.3(d);
- 16) Falsely accusing prisoners of "appeal system abuse" based on staff refusal to apply "prison mailbox rule" to grievance "submission" dates --CCR15 § 3084.4(a);
