## JOURNAL ENTRY

Monday, April 19, 2004

In response to a written request for mental-health services I submitted several days ago because I've lately been suffering adverse emotional and psychological effects of my loved ones not being able to visit me due to my retaliatory transfer so far away from them on 2/20/04, I was called to the medical clinic at approximately 0930 hours to speak with a prison psychologist named Maresh. However, rather than being allowed to discuss and be helped with the feelings of sadness, loneliness, and isolation I reported in my request for mental-health services, I instead suffered intense mental anguish and emotional distress because Maresh spent the entire session of twenty minutes or so attempting to manipulate me into thinking that I should again try celling with other prisoners and no longer be on single-cell status. Even after I told Maresh that she was upsetting me with such talk and that I did not come there to talk with her about my single-cell status and the history behind why I need and so desperately desire such housing, she continued to hammer me relentlessly about it and even attempted to make me believe that every other doctor who has evaluated and worked with me before her the past decade was wrong and mistaken in their documented and expressed assessments of and recommendations regarding my mental-health conditions and needs. Just recently, from 12/4/03 to 2/20/04, I spent 2½ months being subjected to intense psychological torture when certain employees at the California State Prison in Sacramento County retaliated and discriminated against me in deliberate indifference of my diagnosed and documented mental-health needs. Then, from 2/20/04 to 3/3/04, I was subjected to further psychological torture at this prison, the California State Prison in Los Angeles County, because employees here, in what I have been informed and want to believe was unintentional negligence, caused or allowed me to be unlawfully housed contrary to my diagnosed and documented mental-health conditions and needs. I am therefore so unwilling to allow myself to ever again be put into such situations that I not only am documenting in this journal entry how doctor Maresh chose to respond to my request for professional mental-health counseling, but also plan to formally report today's session with Maresh in a CDC form 1824 ADA accommodation request and/or a CDC form 602 grievance, requesting that my case be kept from Maresh so she may never again be allowed to subject me to the mental anguish and emotional distress she caused me to suffer today with the inconsiderate callousness and insensitivity she verbally demonstrated toward my diagnosed mental-health impairments considered permanent disability and a serious mental-health condition (pursuant to, respectively: 42 U.S.C. § 12101 [the Americans with Disabilities Act] and CCR15 § 3084.7(k); and Coleman v. Wilson (E.D. Cal.) 912 F.Supp. 1282).
