Sunday May 27 2001 Victorian Motorkhana Championship Round 4 Supplementary Regulations

AUTHORITY

The meeting, which is a State Championship Motorkhana, will be held under the provisions of the International Sporting Code of the Federation Internationale de l'Automobile (FIA), the National Competition Rules (NCRs) of the Confederation of Australian Motor Sport Ltd. (CAMS), the National Motorkhana Code, the Victorian Motorkhana Championship Standing Regulations 2001, these supplementary regulations and any further regulations which may be issued. CAMS Permit Number 301/2705/06 will be displayed at the event.

ENTRIES

- a) Entries open Monday May 7th and close 9:30 am Sunday May 27
- b) The entry fee is \$20.00 if received on or before Friday May 25; it is \$30.00 thereafter.
- c) Entry fees for juniors will be half price (ie. \$10.00 and \$15.00 respectively)
- d) The field is restricted to 80 entries and will be accepted in order of receipt.
- e) All entries shall be made on the official entry form and sent to the event secretary.

The organisers reserve the right to refuse any entry without giving a reason.

- f) Drivers must hold a current CAMS Level 2 licence or superior and be a member of a CAMS affiliated car club.
- g) CAMS Personal Accident Insurance will be provided.
- h) Up to four (4) adults plus any number of juniors may compete in the same vehicle, provided this is indicated on the entry form.

THE EVENT

The event will be held at the BP Oasis, 1 Cooper St (cnr Hume Hwy) Somerton 3062
The surface is concrete. The event will consist of a minimum of four and a maximum of ten tests selected from the CAMS Booklet of Motorkhana Tests. The tests may be mirror-images of those in the guide and dimensions may be increased from the specified minima. Timing will be by two hand-held stopwatches.

SCRUTINY

Scrutiny will be conducted between 9:00 am and 10:00 am. Log books (if issued) must be presented.

VEHICLES

All vehicles must comply with the CAMS Group 4H: "Motorkhana Cars". All vehicles must be adequately muffled.

DRIVERS

All competitors must wear appropriate footwear. Drivers of vehicles without windscreens must wear appropriate eye-protection as per CAMS requirements. All drivers of specials must wear a helmet to a standard listed in Schedule D of the General Requirements in the CAMS Manual. No passengers are allowed while the driver is attempting any test. **All drivers must attend the drivers' briefing** at 10:15am.

CLASSES

Vehicles will be categorised as follows :

- A. Production cars, wheelbase up to 2300mm, 2WD or 4WD
- B. Production cars, wheelbase 2301mm-2575mm, 2WD engine over drive, or 4WD
- C. Production cars, wheelbase 2301mm-2575mm, 2WD all others
- D. Production cars, wheelbase over 2575mm, 2WD or 4WD
- F. Specials, Front Wheel Drive
- G. Specials, Rear Wheel Drive, engine away from drive
- R. Specials, Rear Wheel Drive, engine over drive
- L. Ladies *
- J. Juniors * (Over 12 but under 18 at 25/2/01)
- N. Novices * (Drivers who have not scored more than 4 class or outright points in any previous year of VMS competition)

* For classes L, J and N, a handicap system shall operate based on the class of the competing vehicle. Results within the class shall be determined by multiplying each competitor's aggregate time, including any penalties, by the following factors:

A: 0.90 B: 0.90 C: 0.87 D: 0.84 F: 1.00 G: 0.90 R: 0.99

Specials will be as defined in the CAMS manual Group 4H, Article 3 p13-8.

AWARDS

Trophies will be awarded to the first, second and third outright places and to class winners.

PROTESTS

Any protests must be lodged in accordance with Part XII of the NCRs of CAMS.

ABANDONMENT

The organisers reserve the right to abandon, cancel or postpone the event in accordance with NCR 59.

ALCOHOL & DRUGS

Competitors are reminded of the requirements of NCR 145A regarding the consumption of alcohol and drugs (ie. no consumption prior to or during competition).

CATERING

Will be available at the venue.
