GENERAL WEEKEND AGREEMENT (Prices are for entire weekend not daily)

WEEKEND PASS ONLY NO SINGLE DAY PASSES WILL BE AVAILABLE PRE EVENT. ARMBANDS WILL BE HANDED OUT AT THE GATE UPON ARRIVAL (MUST PRESENT PROPER ID AND RECEIPT). THE \$15 FEE (\$25 PER COUPLE) ENTITLES YOU TO ONE (1) TENT SITE, ONE (1) WEEKEND ADMISSION AND MOTORCYCLE PARKING ONLY. ADDITIONAL SINGLE/COUPLE ADMISSIONS MAY BE PURCHASED AT THE AFOREMENTIONED PRICE. VEHICLES MAY BE BROUGHT IN TO UNLOAD YOUR CAMPING EQUIPMENT. ONCE GEAR IS UNLOADED, YOUR VEHICLE MUST BE PARKED OUT SIDE OF THE MAIN FENCED IN CAMPING AREA. THE CAMPGROUND IS IN A SECURED AND WELL-LIT AREA. IF YOU WISH TO LEAVE YOUR VEHICLE INSIDE THE FENCED IN AREA YOU CAN DO SO BUT WILL BE CHARGED \$35 FOR A DRY RV SITE UPON AVAILABILITY. PICKUPS WITH CAMPERS ON THE BED WILL BE CONSIDERED A TENT SITE. ANY VEHICLE OVER 18 FOOT IN LENGTH WILL BE CHARGED THE RV FEE OF \$35. ALL VEHICLES OTHER THAN MOTORCYCLES THAT ARE INSIDE MUST REMAIN PARKED THROUGHOUT THE EVENT FOR SAFETY REASONS. THE ONLY EXCEPTIONS WILL BE THE VENDORS THAT ARE WORKING AT **"THUNDER IN THE VALLEY"** IN JOHNSTOWN AND CAMPING WITH US. THESE SUPPORT VEHICLES WILL BE LOADED IN THE MORNING FOR THEIR TRIP TO JOHNSTOWN.

LIABILITY: THE USER ASSUMES THE RESPONSIBILITY AND LIABILITY FOR INJURY TO PERSONS OR DAMAGE TO PERSONAL PROPERTY.
